

All- Council Jacksonville Chamber Golf Tournament 2018

PREMIUM SPONSORSHIP AGREEMENT

This sponsorship Agreement (“Agreement”) is entered into by: _____, (the “Sponsor”) and the Jacksonville Regional Chamber of Commerce, Inc.’s South Council and West Council (collectively: the “Organizer”), effective on the date it is last signed by the Parties.

RECITALS

The Organizer will organize a promotional Golf Tournament at Deer Creek Golf and Country Club (the “Tournament”), scheduled for 10/01/2018.

The Tournament is expected to attract more than 90 golfers from the Jacksonville area business community.

The Organizer is offering sponsorship opportunities for area businesses, including (9) premium sponsorship levels, which are subject to this agreement.

AGREEMENT

1. Premium Sponsorships

2. Organizer’s Representations:

A. To maximize the value of premium sponsorships, Organizer will limit their availability to (1) Title Sponsor, (1) Gold Sponsor, (1) Cart Sponsor, (1) Lunch Sponsor, (1) Putting Contest Sponsor and **LIMITED** Silver, Bronze, Hole and Pin Flag Sponsors.

B. The Organizer will extend to Sponsor the benefits described below for each level:

CART SPONSOR (\$2,500 due within 30 days of signing to be sponsor)

- Name displayed on all golf carts utilized by the players during the tournament.

PUTTING CONTEST SPONSOR (\$1,000 due within 30 days of signing to be sponsor)

- Includes signage on putting green
- Name listed on tournament literature, including the banner
- Recognition at Putting Contest Finals

***TEE BOX SPONSOR (\$200 due within 30 days of signing to be sponsor)**

- Includes full color sign on the course, recognition in the program.

Option to set up a table on your selected hole. Best Hole Sponsor will win a big prize

***PIN FLAG (\$150 due within 30 days of signing to be sponsor)**

- Includes Full Color logo name on the Pin Flag and recognition in the program.
- Pin Flag suitable for being framed.

***Tee Box and Pin Flag Sponsors have limited spots availability. First to pay gets to select their Tee Box or Pin Flag Hole position.**

TERMS AND CONDITIONS

1. Under no circumstances can Organizer be held liable to Sponsor for any damages whatsoever, direct or indirect, liquidated, special, or consequential, in excess of the amount paid by the Sponsor for the Sponsorship.
2. Sponsor agrees to hold Organizer harmless, and indemnify Organizer for any monetary assessment, cost, or attorneys' fees incurred in relation to, any claim, cause of action, suit, petition, or demand of any kind, include arising from Organizer's own negligence, by whomever brought, that arises out of or relates to this Sponsorship Agreement.
3. In case of non-payment by Sponsor by the due date, in addition to withholding the benefits of the Sponsorship and in addition to opening the Sponsorship to another party, Organizer may take any action, including action in Court, to collect payment. Any Court action will be heard by, and Sponsor subjects itself to the jurisdiction of, the Florida state court of jurisdiction in Duval County. Sponsor agrees to pay all collection-related costs incurred by Organizer, including but not limited to attorneys' fees.
4. If any court should hold or find any of the terms and/or provisions of this Agreement void or voidable, such a finding in no way shall affect the enforcement or validity of the remainder of this Agreement or the particular paragraph in which the provision is located.
5. The Parties acknowledge that they have read this Agreement, that they understand its terms and that they agree to be bound by this Agreement. This Agreement shall be construed as if drafted jointly by the Parties, and no presumption or burden of proof shall arise by virtue of its authorship.
